On July 11, 2011, Medical Specialties Distributors, LLC ("MSD") received notice from Smith & Nephew of an Urgent Device Recall Update on certain wipe products. The decision to recall was made at the suggestion of the U.S. FDA. It has been determined that certain Antiseptic Wipes were made in the same facility as another company's alcohol-containing wipes, swabs and swab sticks that are the subject of a voluntary recall due to potential bacterial contamination issue. There is no indication or data to suggest Smith & Nephew products are similarly affected. However, out of an abundance of caution, Smith & Nephew has decided to voluntarily recall the above wipe products.

Our shipping records indicate you received one or more of the manufactured lots of Prep Antiseptic Wipes from the affected lots from 04/06/2010 through 7/27/2010 and may still be in possession of these items.

Please check your inventory immediately to identify and return I.V. Prep Antiseptic Wipes from the affected list to Medical Specialties Distributors, LLC according to the instructions listed below.
